The Export-Import Bank of India [hereafter Exim Bank, or the Bank], on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments/ their nominated agencies in developing countries for financing projects involving procurement of goods, civil works, consultancy and non-consultancy services to be contracted to Indian entities.

These Lines of Credit (LOCs) are governed by the Guidelines issued by the GOI from time-to-time. As per the extant guidelines issued vide letter No. 21/3/2015-IDEAS dated December 7, 2015, the Bank is required to carry out a prequalification exercise and provide a list of prequalified bidders to the Borrower for invitation of bids for specific contract packages under the project(s) financed by the LOCs.

In pursuance to the above, the Bank invites Applications from eligible Indian Consultants for prequalification of Project Management Consultant (PMC) for the project of Construction of 1600 Borewells with Handpumps and 8 Small Water Systems, as also rehabilitation and expansion of five water supply systems in Cabo Delgado province in Mozambique under a Line of Credit extended to the Government of Mozambique.

## **Part I: Scope of Consultancy Services**

The Export-Import Bank of India (Exim Bank or the Bank), on behalf of the Government of India (GOI), has approved financing of a project out of a Line of Credit extended to the Government of Mozambique for Construction of 1600 Borewells with Handpumps and 8 Small Water Systems, as also rehabilitation and expansion of five water supply systems in Cabo Delgado province in Mozambique. A part of the LOC shall be utilized for Construction of 1600 Borewells with Handpumps and 8 Small Water Systems, as also rehabilitation and expansion of five water supply systems in Cabo Delgado province in Mozambique for which Exim Bank now seeks applications for prequalification from eligible Indian Consultants for Project Management Consultant (PMC). Refer Part II ITA 4 for eligibility provisions.

### **A) Background and Major Components of the Project**

The objective of the Government of Mozambique is to improve the Water Supply coverage in the project area through planning, design and construction of water supply infrastructures, consisting borewells or small piped systems which is to be include inter alia, community selection, hydrological investigations, design of system, drilling productive boreholes, installation of submersible and handpumps, construction of elevated water tanks, piped water network and design and placement of standpipes with aprons, drainage systems and washing slabs, complete with drawings.

The National Directorate of Water Supply and Sanitation had identified and targeted various communities in all provinces of Mozambique that were in need of water infrastructure. The priorities are communities that had no immediate access to water. The proposed solution for these communities involves creating independent borewells with handpumps and platforms that are robust and simple to operate in these areas with minimum upkeep while being able to serve the future demands of their community. Large communities will be served by small systems consisting of productive borewells equipped with submersible pumps, elevated tanks and distribution through standpipes.

### **Project Area and Beneficiaries:**

The project will be implemented in the provinces of Nampula, Zambezia, Manica, Sofala and Cabo Delgado as indicated below:

## **Components of the project:**

### **1. Construction of 1600 Borewells equipped with handpumps and platform:**

The essential activities involved are as follows:

- a. To conduct Geophysical studies for borewell sites in villages and localities indicated by National Directorate of Water Supply and Sanitation and submit detailed geophysical report before commencing drilling operation.
- b. Mobilization of equipment and setting up camp at each location and preparation of borewell site.
- c. To drill and create mechanical borewells equipped with 4 inch casing pipes with minimum output of 1,000 liters per hour at locations indicated by National Directorate of Water Supply and Sanitation.
- d. To construct concrete platform of 2 meters diameter for the borewells with concrete drainage facility as per specifications provided by National Directorate of Water Supply and Sanitation.
- e. To equip the borewells with Afridev Pumps, as per specification of National Directorate of Water Supply and Sanitation.
- f. To measure water outputs of each borehole and do water analysis and submit laboratory test report of water along with technical details of each borewell.
- g. To conduct community education programme and train selected team of each community for the operation and maintenance of the borewell and the handpump.
- h. Preparation of work progress report by a team of supervisors appointed by National Directorate of Water Supply and Sanitation.
- i. To give technical assistance and performance guarantee for a period of minimum one year.
- j. Demobilization of all equipment and camping materials.

### **2. Design and Construction of 8 Small Water Systems including rehabilitation and expansion of five water supply systems in Cabo Delgado province:**

For this project, larger rural communities (upwards of 2500) will also be considered. For such communities, instead of having individual borewells fed directly from an aquifer or underground source, small water systems are considered. A small water system includes:

- a. Elevated Water Tanks either constructed or on stands;
- b. A Pipe Network built through the community;
- c. Stand Pipes and / or Washing Slabs at which water is distributed from the Network;
- d. Borewells to supply water for at least 20 years;
- e. Pumping Equipment to supply the Tanks and Network;
- f. Platforms for the Stand Pipes and Washing Slabs to ensure effective drainage.

In Cabo Delgado province, the intervention will consist on rehabilitation of the existing facilities in five water supply systems in the districts of Mueda, Nangade and Muidumbe. The intervention will consist of rehabilitation and expansion of the existing networks estimated in 5 km in each system including replacement of pumping equipment and power supply.

## **B] Scope of Work**

The services of the PMC shall broadly include but not limited to the following:

- Tender Engineering, including Preparation of Technical Specifications, Tender documents;
- Assistance in Tender evaluation and recommendation of award of Engineering Procurement and Construction (EPC) contract;
- Technical assistance in finalization of Bills of Quantities (BOQ);
- Review of designs;
- Synchronization of shipments from India by EPC contractor in tandem with physical progress and site preparedness;
- Inspection of materials at manufacturer's works before dispatch to site;
- Supervision of civil works, and monitoring of implementation of the project;
- Certification of work progress and invoices including the requirement of 75% Indian Content in each contract;
- Weekly/monthly/quarterly progress reports during the implementation of the project;
- Flagging of foreseen delays in the project on timely basis;
- Monitoring of training / skill development activities carried out by EPC contractor;
- Evaluation of operations and maintenance;
- Post-commissioning stages of a project;
- Any other specific requirements specified by the Borrower in tender documents.

## **C] Contract execution period**

The total duration of the Contract is expected to be 38 months.

## **D] Project Authority**

The National Directorate of Water Supply and Sanitation, an institution of the Ministry of Public Works, Housing and Water Resources, Government of Mozambique is the Project Authority.

## **E] GOI Guidelines**

As per the GOI guidelines, goods, works and services for minimum 75% value of the contracts covered under these Lines of Credit, must be sourced from India. ## Part II. Instructions to Applicants

### A. General

- 1. Background**
  - 1.1 The Export-Import Bank of India (hereinafter called “the Bank”), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called “Lines of Credit”) under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called “Borrower or Employer”), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement.
- 2. Scope of Prequalification**
  - 2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (DS), this Application Document (“Application Document”) is being issued by the Bank to prospective applicants (“Applicants”) interested in submitting applications (“Applications”) for prequalification as per the scope described in Part I, Scope of Consultancy Services and subject to the provisions of this Application Document.
- 3. Ethics and Integrity**
  - 3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts<sup>1</sup>, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.
  - 3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.
  - 3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process, or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,
    - a. shall reject any Application for prequalification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
    - b. may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.

<sup>1</sup> These acts shall include, but not limited to, corrupt practice, fraudulent practice, collusive practice, coercive practice, obstructive practice, and conflict of interest.

#### 4. Eligibility of Applicants

- 4.1 This prequalification exercise is open to only Indian Applicants in accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.
- 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant's/ JV Member's Information Form), for any part of the prospective contract(s) including related services.
- 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the subsequent contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV so as to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the **DS**.
- 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is constituted, incorporated or registered in, and operates in accordance with the provisions of the laws of India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
- 4.5 An Applicant that has been blacklisted/ debarred/ sanctioned by any Multilateral Development Agency (MDA) or any authority in India or the borrowing country in accordance with extant rules and procedures, shall be ineligible to participate in the prequalification/ bidding process as applicable, during such period of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned post the prequalification process (i.e. including, during bidding process and Project implementation phase), the Applicant shall immediately inform Exim Bank of such blacklisting/ debarment/sanction and reasons thereof. This may lead to cancellation of prequalification / contract.
- 4.6 The list of debarred firms and individuals by certain leading MDAs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDA's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be prequalified if it is currently under default on any loan to any Bank/ Financial Institution (FI) as per Central Repository of Information on Large Credits (CRILC) database and its account has been classified as Non-Performing Asset (NPA) with any Bank/FI or their companies/ promoters/ directors appear in Reserve Bank of India (RBI) Caution List, RBI Wilful Defaulter List (Suit filed as

well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and any other negative list of central and state government agencies, updated from time-to-time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and Project implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons for inclusion thereof. This may lead to cancellation of prequalification / contract.

- 4.8 An Applicant shall furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.

**14. Authorized Signatory and Number of Copies**

- 14.1 The Applicant shall prepare one original of the documents comprising the Application as described in ITA 10 and clearly mark it "ORIGINAL". The original of the Application shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Applicant. In case the Applicant is a JV, the Application shall be signed by all members of the JV.

**15. Preparing the Application Envelope**

- 15.1 The Applicant shall enclose the original Application in a sealed envelope that shall:
- (a) be addressed to the Bank, as per ITA 16.1;
  - (b) mention the name and address of the Applicant; and
  - (c) mention the specific identification of this prequalification process indicated in the **DS** ITA 2.1.
- 15.2 The Bank will accept no responsibility for not processing any envelope that was not prepared as required in ITA 15.1 above.

**16. Application Submission Deadline**

- 16.1 Applicants must submit their Applications in dual mode (on-line as well as off-line). Applications shall be received by the Bank at the address and no later than the deadline indicated in the **DS**.
- 16.2 The Bank may, at its discretion, extend the deadline for the submission of Applications by amending the Application Document in accordance with ITA 7.

**17. Late Applications**

- 17.1 Applications received after the deadline for submission of applications shall not be admissible, and if received, shall be returned unopened to the Applicant.

**18. Opening of Applications**

- 18.1 The Bank shall open all Applications at the date, time and place specified in the **DS**. Applicants' representatives may be present during opening.

**D. Procedures for Evaluation of Applications**

**19. Evaluation to be Confidential**

- 19.1 Information relating to the Applications, their evaluation and result shall be confidential and will not be disclosed to Applicants or any other person(s) not officially concerned with the prequalification process until the official notification of prequalification results is made in accordance with ITA 25.

	19.2	From the deadline for submission of Applications to the time of notification of the results of the prequalification in accordance with ITA 25, any Applicant who wishes to contact the Bank on any matter related to the prequalification process (except as specified in ITA 20.1 below), may do so only in writing. Canvassing in any form will be grounds for disqualification.
<b>20. Clarifications during Evaluation</b>	20.1	During the evaluation of Applications, in case of ambiguity, the Bank may, at its discretion, ask an Applicant for a clarification of its Application, to be submitted within a stated reasonable period of time.
